## Pioneer Cabinetry Giveaway Terms & Conditions

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.**

By entering a Pioneer Cabinetry Giveaway (each, a “**Giveaway**”), you will be bound by these Terms & Conditions and you acknowledge that you satisfy all eligibility requirements.

“**Pioneer Cabinetry**” means Pioneer Cabinetry LLC or any of its affiliates.

**Eligibility.** Open to individual legal residents of the 50 United States or the District of Columbia and Canada and are the legal age of majority in their state or country of residence prior to the date of entry. Employees of Pioneer Cabinetry and its affiliates, and their immediate family members are not eligible to participate.

**Prize(s) and Winner Selection Method.** The Sponsor will award a prize to one or more individuals who enter at the Giveaway point of entry (“**Giveaway Landing Page**”) using the selection method identified below. Potential winner(s) will be selected at random from among all eligible entries received. Odds of winning depend on the number of eligible entries received. If you are a winner, an e-mail notification will be sent to you Pioneer Cabinetry on behalf of the Sponsor.

Limit one entry per person and household. Each winner will be responsible for paying any taxes and any other expenses incurred, including any income taxes, sales or use taxes, value added taxes, goods and services taxes, or harmonized sales taxes. Throughout the term of this Giveaway, you will provide Pioneer Cabinetry with any forms, documents, or certifications as
